WHEREAS: pursuant to their inherent rights and powers and those granted under the *Indian Act*, R.S.C. c. I-6, the Council of the Piikani Nation is empowered to make decisions on behalf of the Piikani Nation:

AND WHEREAS: pursuant to s. 2(3)(b) of the Indian Act a majority of the Council had a duly convened meeting on the 16th day of September, 2014;

AND WHEREAS: the Council has determined through public consultation that there is support for certain amendments to be made to the *Piikani Nation Election Bylaw, 2002* (the "Bylaw"), and that the amendment of same should be put to a referendum pursuant to s. 15.02 of the Bylaw (the "Referendum");

AND WHEREAS: the form of the proposed amendments was introduced to the Council on August 18, 2014, and passed First Reading pursuant to Band Council Resolution 2014-0818-06;

AND WHEREAS: the form of the proposed amendments was read to the Council a second time on September 16, 2014, and passed Second Reading pursuant to Band Council Resolution 2014-0916-08;

AND WHEREAS: the proposed amendments have this day been read a third time, and the Council has approved same, subject to the approval of the Members of the Piikani Nation by Referendum;

THEREFORE BE IT RESOLVED

1. The Council of the Piikani Nation hereby passes the following amendment to the *Piikani Nation Election Bylaw, 2002* at Third Reading, subject to the approval of the Members of the Piikani Nation by Referendum:

That section 8.01 be replaced with the following:

TENURE

8.01 Commencing with the Piikani Nation Election in the year 2015, the Chief and Councillors elected to the Piikani Nation Council shall hold office for a term of approximately three (3) years commencing at 8:00 a.m. local time the day following the Piikani Nation Election date on which they are elected and terminating at midnight of the next Piikani Nation Election date.

- 2. If it is approved by the Members of the Piikani Nation at a Referendum held on October 6 & 7, 2014, this amendment shall be deemed to have come into force on October 8, 2014.
- 3. The CEO of the Piikani Nation is directed to publish this Band Council Resolution forthwith, and to prepare information packages for the Piikani Nation Membership to be distributed forthwith.
